This degree is designed for individuals who wish to serve as counselors in community-based agencies - for example, mental health, social services, college counseling and probations. The degree provides extended research-based knowledge and skill development in the areas of group and individual counseling, testing, diagnosis and treatment planning.

Students who successfully complete the CMH program are eligible to apply for the license for mental health counselors. The degree in Counselor Education - Clinical Mental Health Counseling **Does Not** meet the criteria for professional teaching certification in the state of New York; the degree in School Counseling **Does** meet such requirements.

## Admission Requirements

The admission committee reviews the following in considering candidates for this program:

1. Application for admission
2. Statement of Intent/writing sample (questions provided)
3. Transcripts from all colleges previously attended
4. Two Professional References (i.e. former professor, supervisor, colleague). – Ability to do graduate work. References from family or friends will not be considered
5. Interview
6. Additional information, if requested by program director

## Field-Experience Requirements

Students are expected to complete a Practicum and two track-specific Internships, each involving 300 clock hours. Site supervisors must have at least three years of experience, be a licensed mental health provider, and hold the qualifications as dictated by the Office of Professions. The placement process is a collaborative effort between students and the Director of Program Administration.
